

#### PRECAUTIONARY STATEMENTS

### Hazards to Humans and Domestic Animals

CAUTION: Harmful if swallowed. Avoid inhalation of vapors. Avoid contact with skin, eyes, or clothing. Wash contaminated skin promptly with soap and warm water. For eyes, flush with plenty of water. # Statement of Practical Treatment

IF INHALED: Remove victim to fresh air. Apply artificial respiration if indicated.

Remove contaminated clothing and wash affected areas IF ON SKIN: with soap and water.

IF IN EYES: Flush eyes with plenty of water. Get medical attention, if irritation persists.

NOTE TO PHYSICIAN: Chlorpyrifos is a cholinesterase inhibitor. Atropine by injection is antidotal only if symptoms of cholinesterase inhibition are present.

# Physical and Chemical Hazards

Use one canister for each 5,000 cu. ft. of unobstructed area. Example 25' long x 20' wide x 10' high = 5.000 cu. ft. Use additional units for remote rooms or where free flow of the mist is not assured. Do not use in an area less than 3,000 cu. ft.

PREPARATION: Cover exposed foods, dishes, and food handling equipment. Open cabinets and doors to areas to be treated. Shut off fans and air conditioners. Put out all open flames except pilot light Remove pets and cover fish tanks or fish bowls with paper, or remove from area. Close exterior doors and windows.

TO START FOGGING: Place Fogger on table, chair or stand, in center of area, at least six feet from pilot light. Place several thicknesses of newspapers under canister to prevent marking of surface. Hold can at arm's length, with top of can pointing away from face and eyes. Push down on finger pad until it locks - this will start fogging action. Set canister in upright position on table, etc., and leave building at once.

DO NOT RE-ENTER BUILDING FOR TWO LOURS, then open exterior doors and windows and allow to air for one hour before reoccupying area. If additional units are used for remote rooms or where free flow of mist is not assured, increase airing out time accordingly.

#### STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Storage: Store in original container in cool, locked storage area away from heat or open flame.

<u>Disposal:</u> Replace cap and discard container in trash. Do not incinerate or puncture.
