

## PRECAUTIONARY STATEMENTS

#### Hazards to Humans and Domestic Animals

CAUTION: Harmful if absorbed through skin or inhaled. Causes moderate eye irritation. Avoid contact with skin, eyes or clothing. Avoid breathing vapors. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash clothing before reuse. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals. It is recommended that professional groomers wear waterproof gloves when using this product. Do not use on puppies and kittens under twelve (12) weeks of age. Consult a veterinarian before using this product on debilitated, aged, pregnant or nursing animals or animals on medication. Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

#### Statement of Practical Treatment/ First Aid

IF SWALLOWED:

Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor.

IF ON SKIN OR CLOTHING:

Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

IF IN EYES:

Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes then continue rinsing eyes. Call a poison control center for treatment advice.

<u>IF INHALED:</u>

Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice.

Have the product container or label with you when calling a poison control center or doctor or going for treatment.

#### **Environmental Hazards**

This product is toxic to fish and other aquatic animals. Do not contaminate any body of water with this concentrate or dip or by cleaning of equipment.

#### Physical or Chemical Hazards

Do not use or store near heat or open flame.

#### **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**SHAKE WELL BEFORE USE.** This product must be diluted before use. Shake or stir thoroughly before using or reusing the final diluted emulsified solution.

<u>To Kill Fleas, Lice and Ticks:</u> Dilute 2 fluid ounces (4 tablespoons), with one gallon of water. Dip animal into solution, or sponge on solution, making sure hair is thoroughly wet to the skin. The area around the ears should be sponged thoroughly. Avoid contact of material with eyes and mouth of animal.

Pet Dip Concentrate gives residual control and repellency of fleas and ticks on dogs and cats. Repeat application every two weeks or as necessary.

#### STORAGE AND DISPOSAL

**STORAGE:** Store in a cool, dry place. Keep container closed.

**DISPOSAL:** Securely wrap original container in several layers of newspaper and discard in trash.
