# PRECAUTIONARY STATEMENTS Hazards to Humans & Domestic Animals

CAUTION: Harmful if swallowed. Avoid inhalation of vapors. Wash contaminated skin promptly with soap and water after use. Avoid spraying food or foodstuffs. Remove birds and cover fish aquariums before spraying.

### Statement of Practical Treatment

IF SWALLOWED: Contact a physician or Poison Control Center. Induce vomiting by touching back of the throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person.

IF IN EYES OR ON SKIN: Flush affected areas with plenty of water. Contact a physician if irritation persists.

IF INHALED: Remove affected person to fresh air. Apply artificial respiration if indicated.

#### STORAGE AND DISPOSAL

STORAGE: Store in original container in a cool dry place inaccessible to children and pets and away from heat and direct sunlight. Protect from freezing.

DISPOSAL: Do not reuse empty container. Wrap container in several layers of newspaper and discard in trash.

# ON PETS

Start spraying at the tail, moving the dispenser rapidly and making sure that the animal's entire body is covered, including the legs and under body. While spraying, fluff the hair so that spray will penetrate to the skin. Make sure spray wets thoroughly. Do not spray into eyes, face or on genitals. Repeat as necessary. To not spray on nursing females or pets under six weeks of age.

### FOR EAR MITE CONTROL

DIAGNOSIS: Ear mites usually induce the formation of a dry, dark brown, waxy exudate with crusts in the ears of dogs, cats, rabbits. Ear mites may be detected by placing some of the ear exudate on a dark surface and carefully watching for the movement of tiny white specks away from the exudate. Inflamed, watery, or blocked ear canals indicate a more serious condition which requires the services of a veterinarian.

**APPLICATION:** While holding pet firmly, fill each ear canal half full of product and massage base of ear to insure that insecticidal action penetrates ear wax. Repeat treatment every other day until condition is relieved. Improvement is usually noted after two applications.

# ON LIVESTOCK

To protect cattle, horses and hogs from Horn Flies, House Flies, Mosquitoes and Gnats, apply a light mist sufficient to wet the surface of the hair. To control Stable Flies, Horse Flies and Deer Flies, apply at a rate of 2 ounces per adult animal sufficient to wet the hair thoroughly. Repeat treatment daily or at intervals necessary to give continued protection.

To control **Blood Sucking Lice**, apply to the infested areas of the animal, using a stiff brush to get the spray to the base of the hair. Repeat every 2 to 3 weeks if required.

To control **Poultry Lice**, spray roosts walls and nests or cages thoroughly. This should be followed by spraying over the birds with a fine mist.

For control of **Bedbugs** and **Mites** in poultry houses, spray crevices of roost poles, cracks in walls, and cracks in nests where the **Bedbugs** and **Mites** hide.

#### ON PREMISES

To control **Fleas** and **Brown Dog Ticks** on premises: Thoroughly spray infested areas, pet beds, resting quarters, nearby cracks and crevices, along and behind baseboards, moldings, window and door frames, and localized areas of floor and floor covering. Fresh bedding should be placed in animal quarters following treatment. Concurrent treatment of animals is recommended. Repeat treatment as needed.
