If these directions do not agree with your product's design you must propose your own labeling and resubmit it for our approval.
- 4. Submit two copies of the revised final printed label for the record. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.

- Invert the applicator tube upright and go to the dog's tail. Position the tip of the tube at the base of the tail and apply the remaining contents of the tube to the base of the dog's tail.
- Reapply every 30 days.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage and disposal. Store in a cool, dry place. Do not reuse empty tube. Wrap and discard in trash.
