Self-treating Dust Bag - For the control of horn ties and as an aid in the control of face flies and lice, out dust in cotton cioth or double burian bags er use prepacked weather-proof cattle dust bags. Hang in barn door exits or alleyways leading from animal buildings, salt or mineral blocks, or watering holes. Protect cloth or burlap bags from weather. Dust bans may be used free choice in loafing pens. feedlots, near watering holes or other areas where cattle gather. The free choice use aids in the control of lice.

STORAGE & DISPOSAL

Storage - Do not store in areas of excessive moisture or humidity. Store in a well ventilated area away from heat and open flame. Pesticide Biposal - Do not contaminate water, food, or feed by storage or disposal. Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. Container Disposal - Completely empty can into application equipment. Then dispose of empty can in a sanitary andfill or by incineration, or if allowed by state and local authorities, by burning, if burned, stay out of smoke.



STATEMENT OF PRACTICAL TREATMENT -11 Swallowed - Call a Physician or Poison Control Center immediately. Do not induce vomiting or give anything by mouth to an unconscious person. If Inhaled - Remove victim to fresh air, Apply artificial respiration if indicated. If On Skin -Remove contaminated clothing and wash affected areas with soap and water. If In Eyes - Flush eyes with plenty of water. Call a physician if irritation persists.

Protective Clothing: Wear long-sleeved shirt and pants: chemical resistant gloves; shoes and socks.

Note to Physician: Tetrachiorvinphos is an organophosphate insecticide, if symptoms of cholinesterase inhibition are present, atropine sulfate by injection is antidotal. 2-PAM is also antidotal and may be administered, but only in conjunction with atropine.

**ENVIRONMENTAL HAZARDS** 

This pesticide is toxic to fish. Drift and runoff may be hazardous to aquatic organisms in adjacent areas. For terrestrial uses, do not apply directly to water, or to areas where surface water is present or to intertidal areas, below the mean high water mark. Do not contaminate water when disposing of equipment washwater.

PHYSICAL OR CHEMICAL HAZARDS

Do not use or store near heat or open flame. Do not store below 32 degrees Fahrenheit.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

BEEF CATTLE DUST WITH RABOND is a ready-touse insecticide dust which can be applied by hand or through the use of self-treating dust bans. There is no withholding period from last application to slaughter and no withholding period for use of milk

Hand Dusting - For the control of horn flies and as an aid in the control of face flies, apply approximately 2 oz. of dust by shaker can, rotary duster, or by spoon to the upper portions of the back, neck, and poll, and to the face as an aid in the control of face files. Rub in lightly to carry the dust beneath the hair. Repeat as necessary.
