

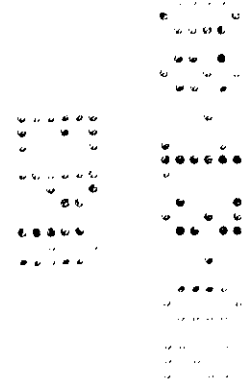

INFORMATIVE: This product is recommended for the control of a wide variety of unwanted vegetation around buildings, along sidewalks and driveways, and under trees and ornamentals. This product may also be used for complete lawn renovation. It is deactivated on contact with the soil.

STORAGE AND DISPOSAL

STORAGE: Do not contaminate water, food, or feed by storage or disposal. Do not store near other pesticides or seeds.

INSTRUCTIONS: This product is ready-to-use. One gallon will cover up to 250 square feet. Apply with sprayer using a nozzle setting that gives a fine spray. Thoroughly cover unwanted vegetation with product.

For spot treatment, spray just a few inches above undesired vegetation.

GENERAL WEED CONTROL: Spray unwanted vegetation thoroughly to the point of runoff. Withering will appear in 1 to 3 days and thorough browning in about 5 to 7 days. Repeat applications may be necessary, particularly for hard-to-kill perennials. The best kill is obtained on young plants during hot, sunny weather.

LAWN RENOVATION: The area to be treated should be mowed before treatment. Bermudagrass and other deep-rooted perennials or uncovered foliage may require a second treatment. Reapply 5 days later if green areas remain. When foliage is all brown, matted areas should be raked and bare spots scarified. About 5 days after last treatment, water thoroughly and then seed at rate recommended for new lawns. Seed must be raked into soil. Keep seeded areas well watered. Do not apply directly or allow spray to come into direct contact with foliage, green bark, grafted unions, or scuffed, damaged or broken bark when spraying around trees or ornamentals.

[REFILL INSTRUCTIONS

Container may be refilled up to 6 times. After 6 refills, dispose of empty container as instructed under Storage and Disposal directions.
