# PRECAUTIONARY STATEMENTS Hazards To Humans & Domestic Animals CAUTION

Causes moderate eye irritation. Harmful if swallowed, absorbed through skin or inhaled. Avoid contact with skin, eyes or clothing. Avoid breathing spray mist. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash clothing before reuse.

#### **Environmental Hazards**

This product is toxic to fish. Do not apply directly to water.

#### Physical and Chemical Hazards

Contents under pressure. Do not use or store near heat or open flame. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause bursting. Do not use this product in or on electrical equipment due to the possibility of shock hazard.

#### **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Not for use on plants being grown for sale or other commercial use, or for commercial seed production, or for research purposes. For use on plants intended for aesthetic purposes or climatic modification and being grown in ornamental gardens or parks, or on golf courses or lawns and grounds.

Do not use in the edible product areas of food/feed processing plants, restaurants or other areas where food/feed is commercially prepared or processed. Do not use in serving areas while food is exposed or facility is in operation. Serving areas are areas where prepared foods are served such as dining rooms but excluding areas where foods may be prepared or held.

In the home, cover all food handling surfaces and cover or remove all food and cooking utensils, or wash thoroughly after treatment. Cover or remove exposed food.

Vacate room after treatment and ventilate before reoccupying. Avoid contamination of feed and foodstuffs. This product is not for use on humans. If lice infestations should occur on humans, use a product labeled for use on humans.

**NON-FOOD AREAS**: This product may be applied in non-food/feed areas. Non-food/feed establishment areas are areas such as garbage rooms, lavatories, floor drains (to sewers), entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, mop closets and storage (after canning or bottling).

#### SHAKE WELL BEFORE USING

Remove protective cap, hold container upright and spray from a distance of 12 to 15 inches. Test product on an inconspicuous area before applying. Spray until surface is slightly wet, but not to the point of run-off. Over application may cause damage. Will not stain surfaces or fabrics where water alone causes no damage. Remove birds and cover fish aquariums before spraying. Prevent re-entry of dogs and cats into the treated area until spray deposits are dry.

Houseflies, Fruit Flies, Mosquitoes, Gnats, Wasps, Hornets, Bees, Black Flies, Skipper Flies, Blow Flies and Small Flying Moths: Close all doors and windows and spray room at the rate of 2 to 3 seconds per 1000 cubic feet. Direct spray to all parts of the room, especially windows and other light sources which attract these insects. Keep nozzle in constant motion.

Cockroaches, Waterbugs, Palmetto Bugs, Silverfish, Firebrats, Crickets, Scorpions, Spiders, Millipedes, Centipedes, Sowbugs and Pillbugs: Spray into hiding places such as cracks and crevices, behind sinks, cabinets, along baseboards and floors, around drains and plumbing, hitting insects with spray when ever possible.



Ants Sapray trails, nests and points of entry. Spray on ants where possible.

Indian Meal Moths, Angoumois Grain Moths: Close doors and windows, direct spray into all parts of room escensive around stored food product containers, pallets and darkened areas. Spray 7 to 10 seconds for each 1000 cubic test of space. Keep area closed for 15 minutes following treatment.

Exposed Stages of Confused Flour Beetles, Saw-toothed Grain Beetles, Red Flour Beetles, Rice Weevils, Grana Weevils, Grain Mites: Spray into cracks and crevices, processing and handling equipment, around cartons or contemporary or other areas where these insects tend to congregate. Spray 30 seconds for each 100 square feet of surface. Keep area closed for 45 minutes to 1 hour after treatment. In the home, dispose of infested stored food products.

Carpet Seetles: Spray directly on beetles, floors, baseboards, shelves and carpets.

Bedbuggs: Spray mattresses, particularly around tufts and seams. Take beds apart and spray into all joints. Treat basecterds, moldings and floors, Allow all sprayed articles to dry thoroughly before reuse.

TO CONTROL Clothes Moths and Carpet Beetles on wool and other proteinaceous fibers: Remove infested articles from storage, brush thoroughly, and air for several hours in sunlight, if possible. Apply spray liberally to empty fraests, closets, bureaus and other storages directing the spray into cracks, joints and crevices. After airing, infested marticles may be treated by spraying lightly, keeping nozzle at least three feet from fabric to avoid staining. Allow all sprayed articles to dry thoroughly before use.

IN ANMAL QUARTERS AND MILK ROOMS: For rapid control of Houseflies, Mosquitoes, Gnats, Wasps, Horness...Bees and Small Flying Moths. Remove animals prior to application. Close windows and doors and spray at the same of 2 seconds per 1000 cubic feet of space. For best results, keep area closed for 10 minutes after spraying...Do not remain in treated area and ventilate after treatment is completed.

TO TRE-AT LIVESTOCK: To protect beef cattle, dairy cattle, goats, sheep, hogs and horses from attacks of Stable Files. -- corse Files, Deer Files, Face Files, Housefiles, Horn Files, Mosquitoes, and Gnats: Spray about 3 seconds on each side being careful to spray back, withers and forelegs thoroughly. To protect from Face Files, spray the face and head, but do not spray into eyes.

FOR SWINE: Do not ship animals for slaughter within 5 days of last treatment.

TO CONTROL Blood Sucking Lice: Apply to the infested areas of the animal, using a stiff brush to get the spray to the base of the hair.

TO CONTROL Poultry Lice, spray roosts, walls and nests or cages thoroughly. This should be followed by spraying over the courds with a fine mist.

FOR CC WITROL OF Bedbugs and Mites IN POULTRY HOUSES, spray crevices of roost poles, cracks in walls, and cracks — nests where the bedbugs and mites hide.

Fleas and Ticks (Adults and Larvae): Remove and thoroughly clean or destroy pet bedding. Spray pet sleeping quarters to bed, entire floor and floor covering, with special attention to cracks and crevices around baseboards, and window and door frames. Infested upholstered furniture may also be treated with this product. Make a test application to upholstery or drapery fabrics in an inconspicuous place before use.

TO CONTROL Fleas and Ticks ON DOGS. Starting at the tail, stroke against the lay of the hair, spraying the parted fur in short bursts, directly behind the hand to insure penetrating the coat. Dampen the fur up to the head. Repeat application every two weeks if necessary.

Do not scoray directly in/on eyes, mouth or genitalia of pets. Use only on dogs. Do not use on cats or kittens. Do not use on puppies less than twelve (12) weeks old. Consult a veterinarian before using this product on debilitated, aged, presonant, medicated or nursing animals. Sensitivities may occur after using any pesticide product for pets. If signs of sensitivity occur, bathe your pet with mild soap and rinse with large amounts of water. It signs continue, consult a veterinarian immediately.

TO KILL \_\_ice and Louse Eggs: Spray in an inconspicuous area to test for possible staining or discoloration. Inspect again after drying, then proceed to spray entire area to be treated. Hold container upright with nozzle away from you. Depress \_\_valve and spray from a distance of 8 to 10 inches. Spray each square foot for three seconds. Spray only those garments and parts of bedding, including mattresses and furniture that cannot be either laundered or dry cleaned \_\_Allow all sprayed articles to dry thoroughly before use.



FOR THE CONTROL OF GARDEN INSECTS: For use on roses, dahlias, asters and other ornamentals to kill Japanesse Beetles hit by spray, as well as Whiteflies, Aphids, Exposed Thrips, Spiders, Red Mites and Leafminners.

May be used on plants, as well as a multi-purpose spray in small gardens and for spot treatments of incipient insect infestations to prevent spreading in large garden areas.

May assisbe used on other plants such as African violets, asters, azaleas, begonias, camellias, carnations, chr.sammemums, dahlias, delphiniums, dogwood, English ivy, Euonymus, fuchsia, geraniums, crassula, grape vine, Kentia staim, laurel, marigolds, rhododendrons, roses, rubber plants, snapdragons, stocks, wandering Jews and zinnias

Effective when used as directed against *Whiteflies, Aphids, Spider* and *Red Mites, Exposed Thrips, Lace Bugs, Japanesse Beetles, Pavement Ants, Clover Mites* and *Armyworms.* When spraying plants, do not operate closer than 15 miches. Use sweeping motion. Spray in one second bursts. Be cautious about wetting tender foliage, young plants and new growth. Do not spray plants when temperatures exceed 90°F. Over application may cause damage. Contact insects directly whenever possible.

#### STORAGE AND DISPOSAL

Do not appreciate water, food or feed by storage or disposal.

Storage: Store in a cool, dry area away from [inaccessible to] children and pets and away from heat, sparks and open farme. Do not transport or store below 32°F. [Protect from freezing.] [Do not freeze.]

Disposa:: Do Not Puncture or Incinerate! *If empty:* Place in trash or offer for recycling if available. *If partly filled:* Call year local solid waste agency or 1-800-CLEANUP for disposal instructions.
