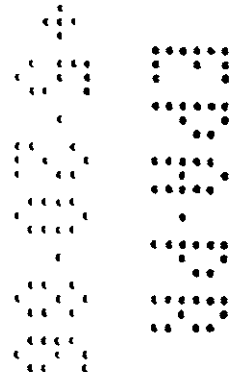

letter, a revised Confidential Statement of Formula on
an up-to-date form, containing a Certification of
Limits for each component in the formulation (see block
14) and an appropriate CAS Number for Fragrance CHN 972.
3. Submit five (5) copies of final printed labeling
before the product is released for shipment.

We have reviewed your letter of May 5, 1986 requesting the use of an alternative fragrance (alternative formula) for this product. This is acceptable provided that:

You submit, within thirty (30) days of the date of this letter, a Confidential Statement of Formula (CSF) on an up-to-date form for the alternative formula. This revised CSF must contain a Certification of Limits (see block 14) and list an appropriate CAS Number for the alternative fragrance (Penny Royal Fragrance).

For your convenience, I have enclosed an up-to-date version of the Confidential Statement of Formula.
