DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Dilutions of this concentrate should be made shortly before use in the quantity needed for the individual application. Water dilutions should not be kept for future use.

To Control Insects in Kennels and Animal Quarters.

Dilute at the rate of 13 fluid ounces in 1 gallon of water or 2 fluid ounces in 18 fluid ounces of water.

Remove pets before treating area and ventilate thoroughly before allowing them to re-enter treated area.

For rapid clean out of fleas and ticks in kennels, apply this delution in a good machine adjoined to deliver coarse droplets. Apply to the point of runoff with special attention to cracks and crevices and other insect hiding places. Bedding should be removed. After spraying, replace with fresh bedding.

To control flies, mosquitoes and gnats in kennels, apply this dilution in a good sprayer adjusted to deliver a fine mist. Use at the rate of approximately 1 ounce for 1000 cubic feet of space. Fill the enclosed area with mist wherever practical. Keep doors and windows closed for 10 minutes or more after application. Do not remain in treated areas, and ventilate after treatment is completed. Treat animals with an approved insecticide before returning to treated quarters.

DISPOSAL

Do not reuse empty container. Wrap container and put in trash collection.
