The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comment listed below. Five copies of the finished labeling must be submitted prior to releasing the product for shipment.

It is the Agency's view that unqualified terms, such as "Herbal and Botanical" and Water Base – Non Oily," are misleading health and safety claims and therefore constitute misbranding under section 2 (q) (1) (A) of FIFRA. Therefore, you must remove these claims from your product label.



FOR USE ON DOGS AND CATS

Hold bottle upright and point nozzle opening in desired direction of spray. Spray the animal from a distance of 3 – 12 inches.

Start spraying at the head, moving the dispenser rapidly and making sure that the animal's entire body is covered, including the legs and under body. While spraying fluff the hair so that spray will penetrate to the skin. Make sure spray wets thoroughly. Do not spray near eyes or on face. Repeat daily until fleas and ticks are eliminated.

FOR USE ON HORSES

Spray from a distance of 3 – 12 inches. Make sure spray wets thoroughly the area commonly attached by fleas and ticks. Do not spray into the eyes. Repeat daily until fleas & ticks are eliminated.

Ear Mite & Tick Control

To be used as an aid in eliminating mites and ticks in the ears of cats and dogs and for relief from itching caused by such conditions. Apply 5 drops into the ears twice daily until ticks and mites are eliminated. Do not allow children to apply this product. Use other EPA approved products for treatment of mites and ticks outside the ear.

STORAGE AND DISPOSAL [*Header not required on containers less than 5 gallons*]

Storage: Do not contaminate water, food, or feed by storage and disposal.

Pesticide Disposal and Container Handling: Nonrefillable container. Do not reuse or refill this container.
