The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below:

1. Revise the "Precautionary Statements" section to read as follows: "Harmful if swallowed. Causes eye irritation. Avoid contact with eyes or clothing. Wash thoroughly with soap and water after handling. In case of infection or skin irritation, discontinue use and consult a veterinarian."
2. Add a new section entitled "Statement of Practical Treatment" to read as follows:  

IF IN EYES: Flush with plenty of water. Call a physician if irritation persists.
3. Retitle the "Disposal" section "Storage and Disposal."
4. Move the statement "Avoid contamination of food or foodstuffs." to the beginning of the "Storage and Disposal" section.
5. Submit 3 copies of finished printed labeling prior to releasing the product for shipment."

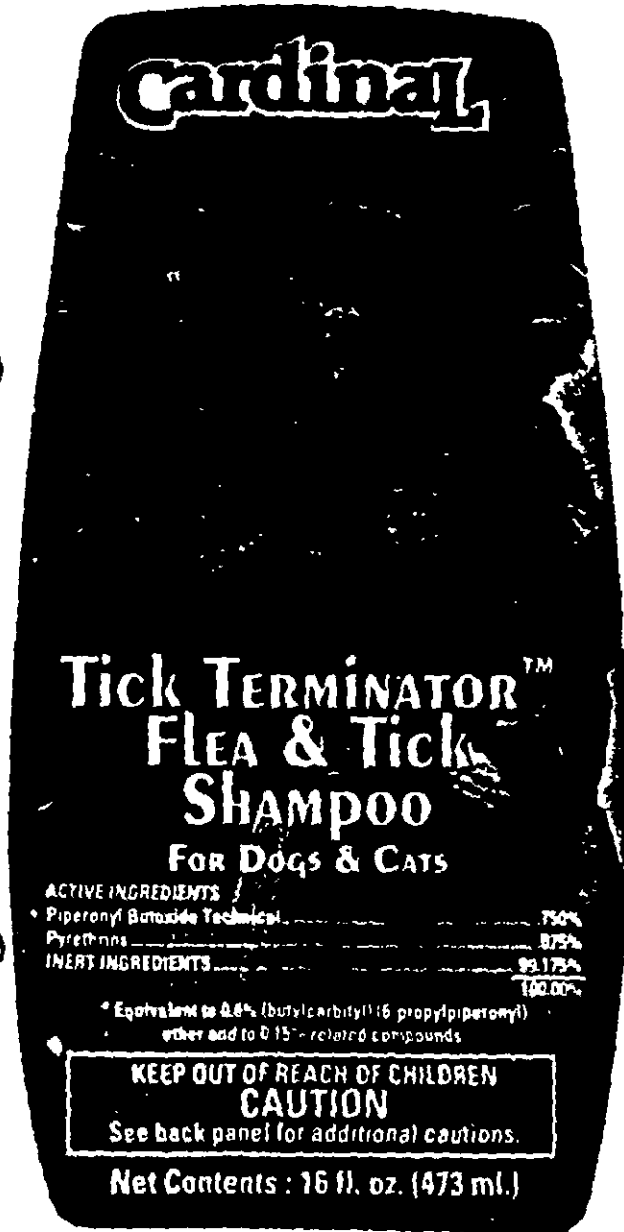
