

Cardinal Insecticide Repellent Spray For Horses has been especially developed for use on horses. It provides a protective hair coating against mosquitoes, flies and gnats while imparting a high sheen to the hair when brushed out. 1 - 2 oz per head per day gives adequate protection. Apply as a fine spray or with a soft cloth. Repeat daily or as required.

#### AS A SPRAY

Cardinal Insecticide Repellent Spray For Horses may be applied as a fine mist to the horse, stable area and over and around stabled horses. Do not wet horse's skin or exceed 2 oz per application.

#### AS A WIPE ON

Before application of Cardinal Insecticide Repellent Spray For Horses, first brush animal to remove excess dirt and dust. Moisten (but do not wet to the point of dripping) a soft cloth and rub over the horse's hair. It is best to apply by rubbing against the hair growth. Give special attention to the legs, shoulders, shanks, neck and facial area where flies, mosquitoes and gnats most often are seen.

Only a light application is required. Avoid using an excessive amount on your horse. Do not wet the skin.

After application, brush out thoroughly to bring out bright sheen on the coat.
