- 3. The subject registration may be combined through conventional breeding with other registered plant-incorporated protectants that are similarly approved for use in combination, through conventional breeding, with other registered plant-incorporated-protectants to produce inbred corn lines and hybrid corn varieties with combined pesticidal traits.
- 4. Planting seed containing this plant-incorporated protectant product may only be planted for the purposes of agronomic evaluation, seed increase, and production in breeding nurseries as specified in the terms of this registration and on the labeling.
