### **DIRECTIONS**

Clean surfaces of gross dirt and filth with soap or detergent solution.

For General Disinfecting: Floors, tile and walls—mop or swab with a solution of 2 ounces Pine Scented Disinfectant per gallon of water. Allow contact time of 10 minutes, then rinse with water.

Trucks for handling animals and stock holding pens: DO NOT use in milking stalls. Remove all animals and feeds from premises, cars, boats, trucks. Remove all litter and manure from floors, walls, and surfaces occupied or traversed by animals. Empty all troughs, racks and other feeding and watering appliances. Saturate all surfaces with disinfecting solution. Ventilate closed spaces, and DO NOT house livestock or employ equipment until treatment has been absorbed, set, or dried. All treated feed racks, mangers, troughs, automatic feeders, fountains and waterers must be thoroughly scrubbed with detergents, and rinsed with potable water prior to reuse.

As a Deodorant: Clean surfaces and use 1½ ounce per gallon of water. Mop or swab on surface.
