

NON-CROP AREAS

For use in killing weeds and grasses on Non-Crop land such as around industrial plants, warehouses, bridges, storage yards, parking lots, fence lines, power and telephone poles, signs, recreational areas and other similar areas where there is no danger to desired vegetation, or where unproductive soil is not objectionable.

HOW TO APPLY: Use a sprayer which will distribute the required amount evenly over the area to be treated. Use a coarse spray to reduce drift. Thoroughly wet all parts of the plant, particularly the growing tips.

WHEN TO APPLY: Best results will be obtained if applied shortly before or at the time plant growth begins. Rain or thorough watering after application will cause the material to move to the root zone and thus speed up control. Avoid application in hot, dry weather.

RATE: For Annual weed control, dilute 1 gallon of product with 4 gallons of water to cover 150 to 200 square feet. For Perennial weed and grass control, apply 1½ gallons of product with sufficient water to cover 100 square feet. Retreatment may be necessary under some conditions to keep areas free of plant growth.

NOTE: DO NOT apply, allow to drift or drain or flush equipment onto or near croplands, lawns, trees or other desirable plants or to areas where their roots may extend. DO NOT contaminate irrigation ditches or water used for domestic purposes. DO NOT allow contact with fertilizers, insecticides, fungicides or seeds. Application equipment should be thoroughly cleaned with a detergent and water to prevent corrosion. Equipment which has been used to apply this product should not be used for applying insecticides, fungicides, fertilizers or other agricultural chemicals as plant injury may result.
