DIRECTIONS FOR USE

For use on non-crop land such as Railroad and Pipeline Right-of-ways, industrial Plants, Lumber Yards, Tank Farms, Storage Areas and Parking Lots for control of most annual and perennial grasses and broadleaved weeds. Effects are slow to appear and will not become apparent until the chemical has been carried into the root zone of the weeds by moisture. Control will last for an extended period. The effectiveness and length of time control will last depend on type of soil, amount of rain and other conditions

HOW TO APPLY: Use a mechanical spreader or other device which will spread the required amount evenly over the area to be treated. It may be applied when top growth is dense, but better control will be obtained when weeds are short or when excess growth is mowed and removed before applying.

WHEN TO APPLY: Best results will be obtained if applied shortly before or at the time plant growth begins Rain or thorough watering after application will cause the material to move to the root zone and thus speed up control. Do not apply when ground is frozen

GENERAL WEED CONTROL

ANNUAL WEEDS AND GRASSES: For foxtail, crabgrass, cheatgrass, wild oats, bromegrass, ryegrass, pigweed, ragweed, turkey mullein, and lambsquarter use 60 to 100 pounds per acre.

PERENNIAL WEEDS AND GRASSES: For quackgrass, bluegrass, smooth brome, Bahiagrass, redtop, purpletop, broomsedge, aster. plantain, dandelion, wild carrot, dog fennel, and goldenrod use 140 to 240 pounds per acre.

For Hard-to-Kill Weeds and Grasses: such as Johnsongrass, Bermuda grass, nutgrass, Dallisgrass, Vasey grass, saltgrass, bouncing bet, dogbane, bracken fern, and horsetail use 300 to 600 pounds per acre.
