DIRECTIONS FOR USE

For use on non-crop areas (utility, highway, pipeline, railroad right-of-ways, lumber yards, tank farms, storage areas, industrial areas) for control of most annual and perennial grasses and broadleaved weeds. Both foliage and root absportion contribute to plant kill. Effects on some species are slow to appear and may not become apparent until the herbicide has been carried into the root zone of the plants by moisture. The degree of control and duration of effect will vary with the amount of herbicide applied, soil type, rainfall, and other conditions; i.e., adsorptive soils (those of heavy texture or high in organic matter) require the higher dosage levels.

HOW TO APPLY: Application may be made with a boom sprayer, hand spray gun, or for small problem areas a sprinkling can. Before applying, calibrate technique to deliver correct dosage necessary to comply with the rates listed below. Thoroughly spray foliage and stems, as well as ground under plants. Apply as a coarse spray to reduce drift.

WHEN TO APPLY: Best results will be obtained if application is made after active growth begins — but before growth has progressed sufficiently to retain more than half the spray. Earlier and later applications also are effective; however, rates near the upper limit of the recommended dosage range may be required. Apply during periods of moderate rainfall. Do not apply when ground is frozen or during other weather conditions which would favor excessive run-off.

USE RATES:

PERENNIAL WEEDS: For field bindweed, leafy spurge, Canada thistle, Russian knapweed, bur ragweed, blueweed and climbing milkweed, apply 200 to 400 gallons per acre; for dandelion, plantain, dock, dog fennel, ragweed and wild lettuce, apply 400 to 600 gallons per acre.

WOODY VINES: For trumpet vine, honeysuckle, kudzu and smilax, apply 200 to 400 gallons per acre.

WOODY BRUSH: For conifers (spruce, balsam fir, cedar and pine), wild roses (Macartney or Cherokee), sumac, persimmon, sassafras, black locust and hackberry, apply 80 gallons per acre.
