Shake Well Before Using

The Cap on this package should be kept in place at all times when not in use.

Hold can 8 to 10 inches from surface to be sprayed. With can upright, point valve opening away from face and press button to spray. For use on plastic trash bags spray all exposed surfaces from bottom to top with coarse wet spray. When properly sprayed surface of bag will have an oily appearance. For use on garbage cans or other type containers a coarse wet spray should be applied from ground level to about 10 inches up the side of container and completely around container. The lid and top edges of container including edges of liner, if used, should also be sprayed. The same oily appearance should appear on cans and other containers as well as plastic bags. A few short bursts sprayed directly into plastic bags or other containers before sealing is also helpful. Directional control of spray can best be obtained at a period when air is calm or wind velocity is low.

Use only for the purposes and in the manner stated on this label. For outdoor use only. This product is not an insecticide, fungicide or a rodenticide, and should not be used as such. Tests indicate one treatment effective 3 to 5 days. After prolonged or extremely heavy precipitation a light reapplication may be necessary.

Contains Capsicum and Mustard Oil. Avoid contact with eyes and skin. Do not inhale spray. Vapor harmful. Use outdoors in well ventilated area. Avoid contact with sprayed surfaces immediately after spraying. Wash hands after using. In case of contact with eyes, flush thoroughly with water - call a physician immediately. **WARNING:** Contents under pressure. Do not puncture or incinerate container. Do not expose to heat or store at temperatures above 110° F. Keep out of reach of children. Intentional misuse by concentrating and inhaling contents can be harmful or fatal. Harmful if swallowed. Avoid contamination of feed, food stuffs, or drinking water. Do not apply to humans, pets or birds.
