DIRECTIONS

TO USE AS A FOGGING INSECTICIDE

After closing off all air currents, direct log, upward at walls and ceilings so that as many insects as possible can be contacted with a direct fog or vapor. Application is to be made with a fogging insecticide applicator. To kill accessible insects: Angoumois Grain Moth and Mediterranean Flour Moth, dispense one (1) quart CMC-3 per 10.000 cubic feet of space. Dispense one (1) pint per 10.000 cubic feet of space to kill flying insects: Flies, Mosquitoes, and Adult Meal Moths. Vacate premises, Doors and windows should be closed for at least one (1) hour after fogging. Ventilate room thoroughly prior to re-entry. Sweep up and destroy all dead and dying insects. Repeat when necessary.

DIRECT CONTACT SPRAYING

To kill Roaches, Crickets, Silverfish and Water-Bugs on premises, direct a wet spray toward infested areas, floors, and crevices to hit the insects. Thorough application should be made repeating treatments as necessary.

After cleaning out bins, mill machinery, and elevators, apply CMC-3 with an efficient hand or power sprayer that will deliver medium size droplets. Repeated treatment is recommended whenever reinfestation occurs.

SPIDERS, MILLIPEDES, AND HOUSE CENTIPEDES

Spray thoroughly and repeat spraying of infested areas, working a wet soray into cracks and other hiding places, directing the spray to hit the pests wherever possible. Repeat applications if necessary.

BROWN DOG TICKS, FLEAS, AND POULTRY MITES

Spray floors, baseboards, wall cracks and hiding places, wetting the surfaces with CMC-3. Apply as a wet spray on chicken perches, nest boxes roosts, lower walls, and floor areas.
