Subject: Amendments - Revise per Diazinon Registration Standard and the Agency's May 1, 1990 Data Call-In letter to reflect only those uses supported by Ciba-Geigy All Season Diazinon 5G EPA Reg. No. 32802-5 Your submission dated February 21, 1990

Dear Mr. Archer:

The amendments referred to above, submitted in connection with a registration under the Federal Insecticide, Fungicide, and Rodenticide Act, are acceptable provided the following revisions are made prior to release for shipment under the amended labeling:

- 1) Revise the the heading "In Gardens D.z.n Kills" to show the correct name for this product (as indicated above in the "Subject" section of this letter) and delete the pests "Armyworms", "Carrot Rust Flies", "Corn borers", and "Rootworms" since these pests are associated with use patterns not being supported by Ciba-Geigy for diaginon reregistration.
- 2) Be sure to use the correct full name for this product (see item "1" above) in any introductory paragraphs, such as that appearing directly under the heading "Overall Lawn Application".
- 3) On page 3, in the "Precautions", revise the end of the fourth sentence to read: "... increase potential hazards to birds and waterfowl.".
- 4) Also in this same "Precautions" section revise the sixth sentence to read as follows:

Where watering is recommended in the directions, or if waterfowl, i.e., ducks or geese, can be expected to enter the treated area after treatment (except spot treatment), water lawn with at least 1/4 inch of water immediately after applying this product, however, stop watering before puddling occurs.

- 5) Relocate the lawn spreader setting table from page 15 to page 4, to the end of the overall lawn application directions, i.e., after the specific directions for Gyperodes weevil control (and above the "Spot Treatment" section). When relocating this table, the following revisions should be made: Since the table will be near the pest listing for overall lawn treatment, delete "Insects listed below" from the top of the right-hand column and delete the list of pests from the bottom of the table. Also, revise the table heading to read "LAWN SPREADER SETTING NO. (To deliver 2 lbs. per 1000 sg. ft.)". Then, in the right column heading, delete "2 lbs" from beneath "Grass or Dichondra Lawn".
- 6) Delete the directions for control of lesser cornstalk borers on beans. Ciba-Geigy has recently notified the Agency that it will not support reregistration of post-emergence application of granular diazinon to beans.
- 7) In the heading for the directions for use on melons, relocate the closing parenthesis mark to appear after "... and hybrids of these rather than after "... and hybrids of these and watermelons".
- 6) The use on radishes to control root macquots, which is crossed out on your submission, should not appear on your finished labeling.
- 9) On page 13. delete "Sweet Corn (Cont'd)", the directions control of European Corn Borer, Fall Armyworm, and Southwestern Corn Borers, and the "Notes" for that crop. Based on the results of avian field studies, Ciba-Geigy has elected not to support reregistration of post-emergence application of granular diazinon to corn. The "Notes" (which deal with picking corn immediately after last application and prohibiting feeding fodder to livestock for 10 days following the last application) are not appropriate to the remaining at-plant soil application use on sweet corn.
- 10) In the second sentence of the Environmental Hazards text, add a comma after "especially waterfowl".

A stamped copy of the label (which superseded your September 15, 1989 submission) is enclosed for your records. Please submit five (5) copies of the revised amended label prior to release for shipment under the amended label. NCTF: When preparing your label, do not print the outtation marks that appear around revised text items specified in this letter. Please refer to the Diazinon Peristration Standard, as amended, for release for shipment and channels of trade dates for diazinon products tearing appropriately amended labels.

Billbugs; White grubs of Japanese beetle, European chafer, Southern chafer, Ataenius spretulus (dung beetle):
Apply 2 lbs. per 1000 sq. ft. of lawn. Water grass thoroughly after application. For billbug control, apply when activity is first observed or when chewed or brown grass indicates damage from these insects. Repeat as necessary. For grub control, except dung beetle, treat any time between late July and early October. For dung beetle grub control, apply in Spring or early Summer when damage is first noticed. Water grass thoroughly with 1/4-1/2 in. of water after application. Treat again in late Summer or early Fall if a second generation occurs.

Hyperodes weevils:

Do not allow children or pets on treated areas until granules have been watered into the soil and the grass or soil is dry.

Statement of Practical Treatment

If swallowed, remove victim to fresh air and apply artificial respiration if indicated.
