- 2) Assure that the net weight of the product is expressed in pounds (lbs.) on page 1 of the product label.
- 3) Per the Label Review Manual, the Container Disposal statement in the Storage and Disposal box on page 2 must read as follows:

"Container Disposal: Nonrefillable container. Do not reuse or refill this container. Completely empty bag into application equipment. 
