Application and Letter Received December 12, 2001, Request To Amend Registration by Revising the First Aid Statements and the Disposal Statements on the Labeling in Compliance with PR Notices 2001-1 and 2001-6; and To Add Minor Marketing Claims and Text

Required by State Fertilizer Regulations

The proposed subject amendments to the registration of "Turf Food With Crabgrass Preventer" have been reviewed and found acceptable under the Federal Insecticide, Fungicide and Rodenticide Act, (FIFRA) as amended, provided that you:

- 1. Revise the 'Optional Marketing Claims" as described here:
 - o Delete the claim: "Kills Crabgrass -- even after germination." This is not a universally true statement.
 - o Delete the claim: "Provides crabgrass control all season long. Again, this is not a universally true statement.
 - o Delete both statements regarding the use of Drop and Rotary Spreaders. There is no need for overlapping application. This would be anti-thematic to the proper application of a pesticide product.
- 2. With any of the alternate wording for warranty statements you must add the commonly used language: "Read the entire "Directions for Use" and "Warranty Statements" before using this product. If terms are not acceptable, return the unopened product container at once to the seller." (You may specify a reasonable time limitation, if "at once" is not preferred.). The above requirement is to assure that you have complied with UCC Articles (Sections 2-719 and 2-316) that apply to the claims for limitation of remedy in the warranty statements.

3. Submit one (1) copy of your final printed labeling prior to your shipment of the subject pesticide product under the enclosed stamped label.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA, section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the proposed label is enclosed for your records.

Please note that the amendments allowed do not involve exclusive use data, therefore a letter of authorization was not required.

GENERAL INFORMATION: This product controls crabgrass and other annual grasses and broadleaf weeds, and also contains fertilizer for proper turf growth in established lawns. It can be applied 2 to 4 weeks later than other crabgrass preventers, and provides up to 3 to 5 months control of crabgrass and other weed grasses and broadleaf weeds in home lawns. It can be applied according to these directions to the following turfgrasses:

Cool season grasses: creeping bentgrass, Kentucky bluegrass, fine fescue, tall fescue, perennial ryegrass;

Warm season grasses: bahiagrass, bermudagrass, buffalograss, carpetgrass, centipedegrass, kikuyugrass, St. Augustinegrass, zoysiagrass.

Apply only to lawns that are well established. Use of this product on lawns that are not well established, or weakened by weather, pests or mechanical stress, may increase the chance for turf injury. This product will not harm nearby established ornamentals when used according to label directions.

When to apply: This product can be applied 2 to 4 weeks later than other crabgrass preventers, because Dimension® herbicide in this product provides preventive (pre-emergence) control when spread on lawns prior to germination of the weed seeds. It also provides postemergence control of crabgrass when applied 2 to 4 weeks after crabgrass germination. Post-emergence control is limited to crabgrass only. Application of this product later than 4 weeks after crabgrass germination will result in reduced control of crabgrass. For control of the weed grasses and broadleaf weeds listed on this label (other than crabgrass), it must be applied as a preventative treatment before the weed seeds germinate. ONLY crabgrass can be controlled with delayed application after germination.

product to pastures. Keep people and pets off treated areas until dust has settled. Reseeding, overseeding, or sprigging of treated areas within 4 months after application of this product may inhibit the establishment of desirable turfgrasses. When seeding, follow good cultural practices such as soil cultivation, irrigation and fertilization. For best results, use "slit seeders" designed to give good seed-to-soil

TIPS FOR IMPROVED CONTROL: For best results, apply this product within a few days after mowing and delay mowing again for a few days after the application. For improved weed control, water or irrigate treated areas within a few days after application. Aerification, raking or dethatching of lawns should be done before application of this product.

WEEDS CONTROLLED: This product will control (at post-emergence rates) or suppress (at pre-emergence rates) these weed grasses and broadleaf weeds when applied before weeds emerge in lawns: crabgrass, annual bluegrass (*Poa annua*), barnyardgrass, crowfootgrass, foxtail (yellow & green)*, goosegrass, kikuyugrass (seedling), common lespedeza, buttercup oxalis, creeping oxalis, yellow woodsorrel, pineappleweed, purslane (common), ryegrass (annual & perennial), smutgrass (seedling), corn speedwell, prostrate spurge, spotted, spurge, bittercress, chickweed, Carolina geranium, henbit, parsley-piert.

*Foxtail is also controlled at the pre-emergence rates.
