APPLICATION RATES FOR ORNAMENTAL PLANTS

Table 2 provides the application rates that will control the pests of land-scape ornamentals and interior plantscapes. Before application, remove black plastic or other weed barrier materials that are impermeable to water. For maximum residual effectiveness or for control of large pest infestations, apply HOWARD JOHNSON'S TURF FERTILIZ-ER PLUS ACELEPRYN INSECTICIDE up to 500 pounds per acre (0.33 Ib AI/A) to control any of the pests listed in Table 2.
