

**PRECAUTIONARY STATEMENTS  
HAZARDS TO HUMANS AND DOMESTIC ANIMALS**

**CAUTION**

Harmful if swallowed. Do not induce vomiting because of aspiration pneumonia hazard. Causes substantial but temporary eye injury. Do not get in eyes, or on skin or clothing. Wear goggles, face shield, or safety glasses when handling this material. Wash thoroughly with soap and warm water after handling. Remove contaminated clothing and wash before reuse. Remove pets, birds, and cover fish aquariums before spraying.

**FIRST AID**

**IF INHALED:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.

**DIRECTIONS FOR USE  
SHAKE WELL BEFORE USING**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

In hospitals, patients should be removed from the room prior to treatment. Room should be ventilated for two hours after spraying. Do not return patients to room until after ventilation.

**SPACE SPRAY TO KILL HOUSEFLIES, MOSQUITOES, GNATS AND SMALL FLYING MOTHS:** Shake container gently to be sure contents are uniformly mixed. Pour in sprayer. Close door and windows and turn off ventilation equipment. Mist all parts of the room or area at a dosage of one fluid ounce of insect spray per 1,000 cubic feet of space. Vacate premises. Keep room closed for 15 minutes. Ventilate prior to re-entry. Repeat as necessary.

**CONTACT SPRAY TO KILL COCKROACHES, WATERBUGS, CRICKETS, CENTIPEDES, SPIDERS, ANTS, SOWBUGS AND EXPOSED FORMS OF CRAWLING GRAIN BEETLES LISTED.** Shake container gently as above. Apply as a coarse spray to all cracks and crevices in woodwork, beneath sinks, dark places behind pipes and in all places where these insects rest, contacting as many insects as possible with the spray. Repeat applications as often as necessary to gain control. For **GRAIN WEEVILS, CADELLES, GRAIN MOTHS, CONFUSED FLOUR BEETLES, SAW TOOTHED GRAIN BEETLES AND GRAIN MITES**, apply as a coarse spray to all infested surfaces, insect hiding places and insect runways at the rate of one gallon of insect spray on 750 square feet of area. Treat ANT trails. Repeat when necessary.

**CONTACT SPRAY TO KILL FLEAS AND BROWN DOG TICKS:** Spray infested areas such as pet resting places and areas of floor and floor coverings (such as carpet) where these pests may be present. Use at the rate of one gallon per 750 square feet of area to be treated. Old pet bedding should be discarded and replaced with clean, fresh bedding after treatment. Do not directly apply to pet. Repeat as needed.
