Pond Block is limited for use in backyard/homeowner ponds and water fountains (maximum 3,000 U.S. gallons [11000 L]). Do not use fish from treated ponds or fountains for food or feed. Pond Block helps clear cloudy water and remove algae from ornamental pond/fountain water. **USE ONE BLOCK FOR WATER VOLUMES BETWEEN 100 AND 250 U.S. GALLONS (380 L - 950 L).** Initial dose may require one block for each 100 U.S. gallons (380 L). For regular maintenance, replace block when fully dissolved (usually after 30 days). Not recommended for use with live plants.

STORAGE AND DISPOSAL:

Pesticide Storage: Store in an area inaccessible to children, water supplies and feed. **Pesticide Disposal:** Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain. **Container Disposal:** Do not reuse this container. Place in trash or offer for recycling if available.
