- 3. Make all the following changes to the product label:
 - a. The First Aid statements "If Swallowed" and "If Inhaled" are optional for this product.
 - b. The Note to Physician statement is optional for this product.
 - c. Change the Hazards to Humans and Domestic Animals statement to read as follows: "Harmful if absorbed through skin. Causes moderate eye irritation. Avoid contact with skin, eyes, or clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Remove and wash contaminated clothing before reuse. Wear long-sleeved shirt, long pants, shoes, socks, and chemical-resistant gloves made out of any waterproof material."

- d. Remove the second paragraph "This pesticide is toxic to fish and aquatic...equipment washwaters or rinsate." under Precautionary Statements.
- e. Change the Environmental Hazards section to read as follows: "This pesticide is toxic to fish and aquatic invertebrates and may contaminate water through runoff."
- f. Change the restriction under Directions for Use to read "Do not apply this product in a way that will contact adults, children, or pets either directly or through drift. Keep people and pets out of the area during application."
- g. Change the use site from "backyard/homeowner ponds" to "backyard/home ponds".
- h. Correct the typo in the application rate from "ON TEASPOON" to "ONE TEASPOON".
- i. The Storage and Disposal statement "Open burning and dumping are prohibited." should be removed or relocated under Pesticide Disposal and Container Handling section.
- j. Remove the Storage and Disposal statement "Do not reuse empty container."
- k. Change the heading from "Pesticide Disposal" to "Pesticide Disposal and Container Handling". Change the text to read "Nonrefillable container. Do not reuse or refill this container. If empty: Place in trash or offer for recycling if available. If partly filled: Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain."
