PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

DANGER: Corrosive. Causes irreversible eye damage. Do not get in eyes, on skin, or on clothing. Wear safety glasses. Harmful if swallowed, inhaled or absorbed through skin. Avoid breathing spray mist. Remove contaminated clothing and wash clothing before reuse. Wash thoroughly with soap and water after handling.

FIRST AID

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

IF SWALLOWED: Call poison center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

WHAT IS THIS PRODUCT? AND WHAT WILL IT DO?

READY-TO-USE MOSS OUT! SPOT TREATMENT is the quick, easy, and convenient way to kill small patches of unwanted moss in lawns and flower beds. This product is ready-to-use and requires no mixing. This liquid iron formulation provides thorough coverage of the moss for superior results. The sturdy container, with its attached sprayer and easy-grip handle, lets you quickly and easily apply just what you need, then safely store the remainder for later use. No need to drag out the hose or separate sprayer to treat small patches of unwanted moss!

Moss growing in lawns competes with the turf, causing the grass to thin-out and create an excessive build-up of thatch. Moss growing in flower beds is unsightly and can harbor insects. Shaded or poorly-drained acidic areas encourage moss growth. Kill unwelcome moss, quickly and easily, with **READY-TO-USE MOSS OUT! SPOT TREATMENT**.

HOW DO I USE THIS PRODUCT?

When to use: Use this product anytime the moss is actively growing. Moss grows most vigorously during the warm, rainy periods in spring and fall, but will grow all year round in some shady areas. Spray whenever and as often as needed to keep moss out of your lawn and flower beds.

What to do: When spraying moss in the lawn, mow the grass a bit shorter than usual to expose more of the moss. To get the most complete kill of the moss or when the moss is very thick, first rake out as much as you can, using a thatching rake or lawn rake. When spraying moss in flower beds, apply when the soil is moist. To improve the appearance of your lawn and flower beds, gently rake out the dead moss a few days after treatment. Since grass may be slow to fill in bare spots, we suggest reseedling with a quality Lilly Miller® grass seed. To reduce soil acidity, which may contribute to moss growth, apply Lilly Miller® Super Sweet™ or Lilly Miller® Soil Sweet™ lime according to label directions.

What not to do: This product is for use on lawns and in flower beds only. Do not let this product contact any other surfaces. It will stain them. Do not allow this product to contact galvanized metal. This product may burn foliage if applied directly to flowers or ornamental shrubs. If contact occurs, use a hose to wash this product off the plants right away. Do not try to cover more area than 50 sq. ft. with this container; it will not be effective. Do not allow adults, children or pets back onto the sprayed area until it has dried.

HOW DO I USE THIS SPRAYER?

Shake well before using. This bottle will cover 50 sq. ft. Remove the child-resistant closure and save it for resealing the container when you are finished. Insert the sprayer hose and cap assembly. Follow directions given with the sprayer when priming and rinsing the sprayer. Adjust the spray nozzle to give small droplets without a fine mist. Spot spray patches of moss evenly and slowly, allowing the spray to thoroughly penetrate the moss. After you are finished spraying unwanted moss, reseal the container with the child-resistant closure.

WHAT WILL I SEE?

The treated moss will turn black within hours, and die within a day or two.

STORAGE AND DISPOSAL

Storage: Store this product in its original container and keep in a secure area out of reach of children and domestic animals. Disposal: If Empty: Do not reuse this container. Place in trash or offer for recycling if available. If partly filled: Call your local solid waste agency or 1-800-CLEANUP for disposal instructions.
