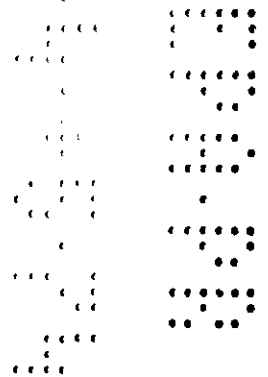

Speer Residual Insecticide is excellent for use in Mills, Bakeries, Food Markets, Furniture Storage and other Warehouses, Hospitals, and Institutions. When used as directed this Residual Insecticide is effective in killing resistant roaches, waterbugs, silverfish, carpet beetles, ants, flies, and granary weevils and rice weevils (exposed stages).

DIRECTIONS FOR USE IN NON FOOD AREAS:

SPOT APPLICATION (DO NOT FOG): Spray only with a coarse wet spray, or paint surfaces.

GRANARY WEEVILS and RICE WEEVILS (exposed stages), ROACHES, WATERBUGS and SILVERFISH: Spray liberally into all cracks, underneath skids, shelves, tables, chairs, around windows, doors, cabinets, machinery and motor bases, and around pipes. Spot-spray walls where insects are seen congregating. Saturate tops and bottoms of baseboards, or where walls and floors meet.

ANTS: Treat as roaches, paying particular attention to surfaces where ants travel, ant trails, and where ants enter a room or building - such as the inside and outside surfaces of window frames, door frames and door sills. Pour Residual Insecticide over and into ant hills. Repeat several times if necessary.

FLIES (outdoors only): Spray or paint on screens and outside walls around doors. Spray all places outdoors where flies congregate. Wet surfaces well, but not to the extent that insecticide runs off. Surfaces subject to dust, frequent cleaning, or weathering may require frequent application.

CARPET BEETLES: Spray heavily wherever these insects are seen or suspected, such as behind baseboards, along edges of carpets, under rugs or floor coverings, in or between floor and baseboard. Repeat spraying every few days. In all cases of insect infestation, repeat above procedures several times.

APPLICATIONS WITHIN FOOD AREAS OF FOOD HANDLING ESTABLISHMENTS: Limited to Crack and Crevice Treatment Only as an aid in controlling Granary Weevils and Rice Weevils. Apply small amount of material directly into cracks and crevices such as expansion joints between different elements of construction or between equipment bases and floor, wall voids, motor housings, junction boxes and switch boxes, conduits or hollow equipment legs where Granary Weevils, Rice Weevils, Roaches, Waterbugs, and Silverfish hide. Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food processing surfaces.

Applications of this product in food areas of food handling establishments, other than as a crack and crevice treatment, are not permitted.

CAUTION: KEEP OUT OF REACH OF CHILDREN

Harmful if swallowed, inhaled or absorbed through the skin. Avoid contact with eyes, skin, and clothing. Skin contact may cause toxic symptoms. In case of skin contact wash with soap and water. Wash thoroughly with soap and water after using. Do not permit children on treated surfaces until surfaces are dry.

Use adequate ventilation. Avoid inhalation. If spraying is necessary, use a respirator approved by the U.S. Bureau of Mines.

This product is toxic to fish. Do not contaminate any body of water by cleaning of equipment or disposal of waste. Do not use on household pets or other animals.

In case of illness, get prompt medical aid. Atropine sulfate is antidotal.

Do not smoke while spraying. Do not use, pour, spill, or store near heat or open flame.
