DIRECTIONS: Important: Hold container only in upright position to spray. Keep spray actuator pointed to mark on valve cup. Direct spray from face. Insert extension tube into actuator and hold container 6 to 12 inches from surface and spray area of infestation. Thorough applications produce a coating that will vaporize into cracks and crevices for insect control. If reinfestations occur, repeat applications as necessary. PAPER NEST WASPS: Apply a wet spray to the nests after dark when all pests have returned to their nests. SCORPIONS, BLACK WIDOW SPIDERS AND OTHER SPIDERS: Spray directly on pests when possible. Treat surfaces of garages and outbuildings where pests hide or congregate. Spray points of entrance such as window sills and along crevices. SILVERFISH: Apply to cracks, baseboards, behind shelving, bookcases and other storage areas. BROWN DOG TICKS: Thoroughly spray cracks, crevices and areas where pets are in the habit of lying down. Do not spray on pets. Allow the sprayed areas to dry thoroughly and replace bedding before permitting use by animals. In treating dog kennels apply to outside dog runways, window sills and ledges. For control of roaches in dog kennels, treat all cracks and crevices. For control of flies, gnats and mosquitoes, spray outdoor surfaces of screens door and window frames and other outdoor surfaces where these pests congregate. FLYING ANTS: Spray directly on swarming ants outdoors. Only spray while ants are swarming on the ground. Do not spray in air,
