DIRECTIONS FOR USE:

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Avoid working near high concentration of spray/mist or vapor. Use with adequate ventilation. Green Label is a preservative formulated to provide maximum preservation on silage, haylage, feed blends, hay, and stored grass forage (alfalfa, bermuda grass, bluegrass, brome grass, clover, cowpea hay, fescue, lespedeza, lupines, orchard grass, peanut hay, peavine hay, rye grass, soybean hay, sudan grass, timothy, vetch, and wheat grass) which is intended only for use as animal feed.

FOR USE ON HAY: Accurately determine moisture content of hay just prior to application. Apply GREEN LABEL with an approved, calibrated set of low pressure spray nozzles achieving uniform coverage. Stop application immediately in event of spray failure or nozzle plugging. Do not store treated bales directly on dirt.

For use on silage, haylage, and feed blends apply at the recommended application rates.

Corn Silage and at 60-70% moisture:	Small grain silage at 60-70% moisture:

Haylage/Baleage at 50-70% moisture:	Feed Blends (short term storage):
2-4 lbs/ton.	1-3 lbs/ton. Increase rate for added stability.

STORAGE AND DISPOSAL:

Do not contaminate water, food, or feed by storage or disposal.

Pesticide Storage: Avoid contamination of stored pesticide with water or caustic. Store in a cool dry place. Keep container out of direct sunlight. Store above -20°F. Keep container closed when not in use.

Pesticide Disposal: Wastes and rinse-water should be used or reprocessed. Wastes can also be disposed of on-site or at an approved waste disposal facility. Open dumping is prohibited.

Container Disposal: Reseal container and offer for reconditioning or triple rinse (or equivalent) and offer for recycling, reconditioning, or disposal in approved landfill.

Pesticide Spillage: Neutralize with sodium carbonate, sodium bicarbonate, chalk, or lime.
