# H - 5 ALGAEICIDE

A Treatment for use in recirculating Commercial and/or Industrial Water Cooling Systems to inhibit the growth of Algae, Bacteria, and Fungi

FIRST AID: If swallowed, give patient doses of powdered charcoal immediately or all he can swallow of raw egg white, milk, gruel, or flour and water. Then induce vomiting with salt, soap, or mustard in warm water. Call a physician immediately. In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Remove and wash contaminated clothing before reuse.

DIRECTIONS FOR USE: H-5 Algaecide is used to inhibit the growth of algae, bacteria, and fungi in recirculating commercial and industrial cooling water systems. Before treatment with H-5 Algaecide systems must be cleaned to remove algae growth, microbiological slime, and other deposits.

INITIAL DOSE: The system should be treated with an initial slug addition of 5.1 to 10.2 fluid ounces of H-5 Algaecide per 1,000 gallons of water in the system. Repeat the initial dosage until control is evident. Slug additions of H-5 Algaecide should be made to the sump of water cooling towers

SUBSEQUENT DOSE: Subsequent slug additions of 1.7 to 10.2 fluid ounces of H-5 Algaecide per 1,000 gallons of water should be made every 1 to 5 days or as needed. The required frequency of treatment depends on the relative amount of bleedoff and the severity of the microbiological problem.

NOTICE: This product is toxic to fish. Treated effluent should not be discharged where it will drain into lakes, streams, or public water. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply the amount of H-5 Algaecide specified on this label. Do not reuse empty drum. Return to drum or conditioner or destroy by incineration in accordance with applicable regulations.
