In air-washing systems, add 8.0 to 13.7 fl. oz. of Culligan M-4025 per 1000 gal, of water to water-collection trays, Repeat treatments every 1-5 days, or as needed. The required frequency depends on mistive amount of bleed and severity of slime problem.
