Dear Ms. DeVito,

The following amendment submitted in connection with registration under FIFRA, as amended, is acceptable with the following conditions.

- Response to Agency letter dated December 29, 2003

Conditions

Revise the label as follows:

1. According to the Label Manual, 3rd edition, the misuse statement, "It is a violation of Federal law to use this product in a manner inconsistent with its labeling," must follow the "Directions For Use" heading.
2. According to PR Notice 84-1, any pesticide product sold in containers 1 gallon or 5 pounds or less can carry reduced Storage and Disposal Instructions. Therefore, you must delete the statement, "Do not contaminate water, food, or feed by storage or disposal," as well as the "Pesticide Disposal" heading and statements.
3. Under the "Precautionary Statements," revise the last statement to read "Remove contaminated clothing and wash before reuse."
4. Revisions for the "Placement Instructions for Commercial Refrigeration" sheet:
 - a) Delete "Important" and replace it with the "Directions for Use" heading and the general misuse statement, "It is a violation of Federal law to use this product in a manner inconsistent with its labeling."


b) Delete "First Aid and Other Precautions" and replace it with "Precautionary Statements. The 2nd statement under the "Precautionary Statements" must be revised to state "Causes irreversible eye damage and skin burns;" the last statement must state "Remove contaminated clothing and wash before reuse."

A copy of the stamped label acceptable with conditions is enclosed. Submit three (3) copies of your final printed labeling before distributing or selling the product bearing the revised labeling.

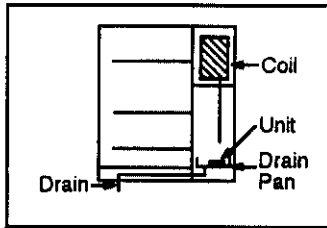

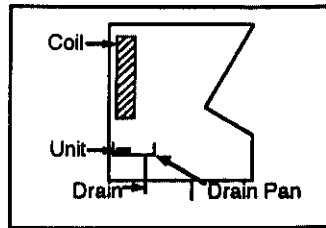

Placement Instructions For Commercial Refrigeration

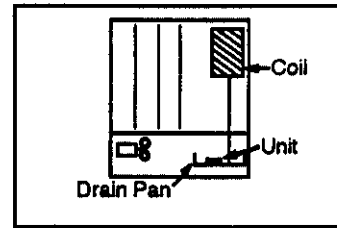
The unit can be placed in the drain pan flat or at an angle, depending upon the space between the refrigeration coil and the drain pan, pad side down.



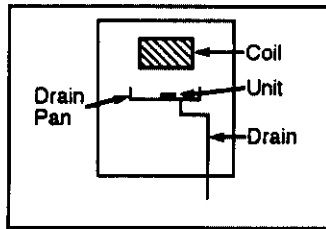

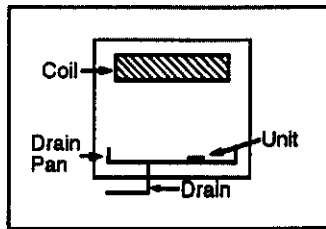

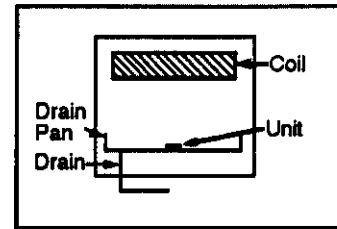
