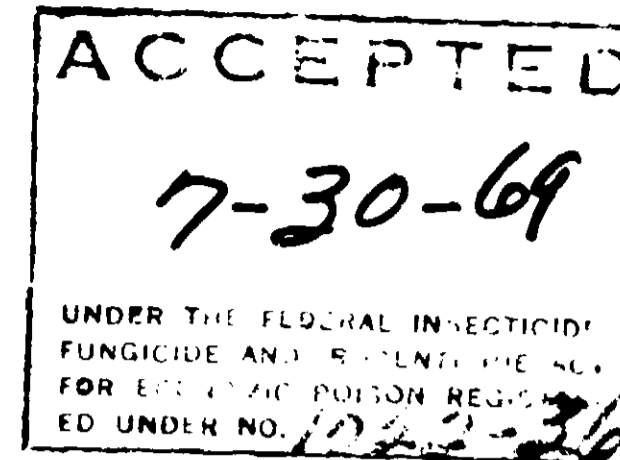

Apply WEED-FREE SW when grasses and weeds are growing and preferably before they are 3 inches high. Best results are obtained when the air temperature is above 70 F.

WEED-FREE SW must be shaken well before each use.

DIRECTIONS

GENERAL WEED AND GRASS CONTROL

Use WEED-FREE SW for post-emergence control of certain annual and perennial grasses, weeds and vines such as watergrass, goose-grass, nutgrass, cocklebur and Johnsongrass. Add the contents of this container to 80 gallons of water. The unwanted vegetation should be thoroughly covered with spray to the point of runoff. Spot retreatments may be necessary and should be made where re-growth occurs. Any spray equipment which will give good spray coverage may be used with power sprayers being particularly effective for such areas as rights-of-way, drainage ditch banks, fence rows, implement storage yards and similar non-crop areas where control of the grasses and weeds mentioned above is desired.
