DIRECTIONS

WEED-FREE BC must be spread uniformly at rates given for effective weed control. Apply with a seeder or granular herbicide applicator. Killing action is primarily through the roots of plants, so moisture is required after application to carry the chemical to the root zone. With too little moisture, results may be slow to appear. Avoid application in hot dry weather.

FOR ANNUALS OR SHALLOW ROOTED PLANTS - Apply ³/₄ pound per 100 square feet.

FOR PERENNIAL AND DEEP ROOTED PLANTS - Apply 1 to 1½ pounds per 100 square feet. Where Johnson, Bermuda and Vasey grasses are a serious problem, apply 1½ pounds per 100 square feet.

FOR BRUSH CONTROL - Apply 1¹4 lbs. per 100 square feet.

FOR SOILS HIGH IN ORGANIC MATTER - Apply 2 lbs. per 100 square feet.

Make application in the spring or whenever weeds and grasses are not over a few inches high. Rank vegetation should be cleared before treatment. This reduces fire hazard of dead weeds and aids in getting more even coverage of the area. USDA Reg. No. 1022-419
