Products: Bareground 21, Barespot Weed and Grass (20 and 50 lbs), Barespot Ureabor,
Barespot Monobor-Chlorate (Greenhouse and Non-Greenhouse Use)

Registration Number: 33560-43, 33560-46, 33560-47, 33560-48

Your Submission Dated: 07/01/03

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended is acceptable, provided you make the following changes before you release the product for shipment.

1. **33560-43 (Bareground 21)**

The label for this product was reviewed when it was submitted for a name change of the product. The changes necessary per PR Notice 2001-1 were noted and mailed in a letter dated 08/07/2003.

2. **33560-46 (Barespot Weed and Grass - 20 and 50 lbs)**

- The signal word must be changed from DANGER to WARNING.
- The NOTE TO PHYSICIAN which reads, "Probable mucosal damage may contraindicate the use of gastric lavage," is only necessary for corrosive or Toxicity Category I Eye or Skin Irritants. Please remove this statement from the label.
- The IF ON SKIN subheading under First Aid should be changed to IF ON SKIN OR CLOTHING
- In the PERSONAL PROTECTIVE EQUIPMENT section, change "Waterproof gloves" to "Chemical resistant gloves made of any waterproof material."
- The order of the First Aid statements and the order of the Hazards to Humans and Domestic Animals statements should correspond, with the most severe routes of exposure listed first. The HAZARDS TO HUMANS AND DOMESTIC ANIMALS section should be changed to "Causes substantial but temporary eye injury. Wear protective eyewear (goggles, face shield, or safety glasses). Avoid contact with eyes or on skin or clothing. Harmful if adsorbed through the skin or swallowed. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash clothing before reuse."

3. **33560-47 (Barespot Ureabor)**

- The order of the First Aid statements and the order of the Hazards to Humans and Domestic Animals statements should correspond, with the most severe routes of exposure listed first. The HAZARDS TO HUMANS AND DOMESTIC ANIMALS section should be changed to "Corrosive. Causes irreversible eye damage. Wear protective eyewear (goggles, face shield, or safety). Do not get in eyes or on skin or clothing. Harmful if swallowed. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash clothing before reuse."

- Move the STORAGE AND DISPOSAL information into the DIRECTIONS FOR USE section, preferably blocked, near the beginning or end of the section. This information is preferred at the end of the DIRECTIONS FOR USE section.
- In the GENERAL PRECAUTIONS AND RESTRICTIONS section add, "Do not enter or allow entry by domestic animals and other persons until dusts have settled. Do not apply product in a way that will contact workers or other persons, either directly or through spray drift. Only protected handlers may be in the area during application."

4. **33560-48 (Barespot Monobor-Chlorate - Greenhouse and Non-Greenhouse Use)**

- In the PERSONAL PROTECTIVE EQUIPMENT and AGRICULTURAL USER REQUIREMENT sections, change "Waterproof gloves" to "Chemical resistant gloves made of any waterproof material."
- The order of the First Aid statements and the order of the Hazards to Humans and Domestic Animals statements should correspond, with the most severe routes of exposure listed first. The HAZARDS TO HUMANS AND DOMESTIC ANIMALS section should be changed to "Corrosive. Causes irreversible eye damage. Wear protective eyewear (goggles, face shield, or safety). Do not get in eyes or on skin or clothing. Harmful if swallowed. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash clothing before reuse."
- Add a NON-AGRICULTURAL USE REQUIREMENTS box that addresses reentry and PPE for reentry for non-WPS users. This box may be placed anywhere in the Directions for Use section of the label after the Agricultural Use Requirements box. The following statements must be contained in the non-agricultural use requirements box:


"Non-Agricultural Use Requirements"

"The requirements in this box apply to uses of this product that are NOT within the scope of the Worker Protection Standard for agricultural pesticides (40 CFR Part 170). The WPS applies when this product is used to produce agricultural plants on farms, forests, nurseries, or greenhouses."

In addition, place into the Non-Agricultural Use Requirements box all the entry restrictions, notification requirements, PPE or other statements and instructions that apply to the non-WPS uses on the label. Examples: "Keep children and pets out of the treated area until sprays have dried." or "Keep unprotected persons out of treated areas until sprays have dried."

Submit three (3) copies of final printed labeling incorporating the above changes before you release these products for shipment. Amended labeling will supercede all previously accepted labels. Stamped copies of labeling are enclosed for your records.

BareSpot® Ureabor is designed for non-selective kill of weeds and grasses with a single treatment. Use for quick knockdown of existing vegetation as well as short season effect in the soil for control of regrowth or new seedlings. Use for general mixtures of weed and grasses. BareSpot® Ureabor is also effective on perennial grasses such as

Johnson grass, Bermuda grass, Dallis grass and Quack grass.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in any manner inconsistent with its labeling.

FOR USE ON INDUSTRIAL SITES OR SIMILAR NON-CROPPED AREAS

IMPORTANT: This material is not selective in action, may be toxic to all types of vegetation, and may render the entire treated area totally or partially unproductive for one or more years. Care should be taken to continue the use of application to the particular area intended to be treated and to avoid its contact with lawns, trees, shrubs, crops and other desirable plants which are not intended to be destroyed or injured. This includes precautions in treating areas which may be underlaid by roots of adjacent desired growths. Use BareSpot® Ureabor anytime during the growing season. Weeds and grasses are easier to kill when they are young and growing rapidly.

GENERAL PRECAUTIONS AND RESTRICTIONS

Not to be used in any recreation areas or in and around homes.

Do not contaminate water used by wildlife and aquatic life, or for domestic and irrigation purposes. Do not apply where run-off is likely or where weather conditions favor movement away from target areas.

APPLICATION INSTRUCTIONS

APPLICATION: For all uses, uniform application is essential. The material becomes effective in the soil followed by rainfall or irrigation. (See applications rates below.) BareSpot® Ureabor is ready to use! Apply with a hand-operated spreader, such as a conventional cyclone type spreader, or a power spreader for larger areas.

Use the following rates of application under most conditions: When using these rates, this product can be applied once per year.

ANNUAL weeds and grasses such as Sunflower, Kochia, Russian Thistle, Pigweed, Crabgrass, Downy Brome.	1- 1.6 lbs./ 100 sq. ft.*
PERENNIAL Weeds and Grasses such as Johnson grass, Bermuda grass, Dallis grass, Quack grass, Canada thistle, Bindweed, Bluegrass	1.8 lbs./ 100 sq. ft.
MIXED Annual and perennial weeds and grasses	1.8 lbs./ 100 sq. ft.
