DIRECTIONS FOR USE

For the control of bacterial, fungal, and yeast growths in pulp, paper, and paperboard mills, add OLIN 7080 at the rate of 0.15-0.50 lb./ton of pulp or paper (dry basis). Addition may be continuous or intermittent, depending upon the type of system and the severity of contamination. It should be made with a metering pump at a location that will insure uniform distribution of OLIN 7080 in the mass of fiber and water, such as the beaters, jordan inlet or discharge, broke chests, furnish chests, save-alls and white-water tanks.

NOTE: ADD OLIN 7080 SEPARATELY TO THE SYSTEM. DO NOT MIX IT WITH OTHER ADDITIVES IN ORDER TO AVOID DECOMPOSITION OF OLIN 7080 DUE TO THE HIGH pH OF MANY ADDITIVE FORMULATIONS.
