LAWN CHINCH BUG AND SOD WEBWORM CONTROL

DIRECTIONS: To control Chinch Bugs and Sod Webworms (Lawn Moths), apply at 1 pound per 1,000 sq. ft. of lawn area. After application, water lawn using - 30 gallons of water per 1,000 sq. ft. of lawn area. For Chinch Bugs, apply when activity or damage appears (yellowing then browning of grass often develops in spots then spreads throughout the lawn). Control will last up to eight weeks. To prevent damage apply as soon as daily temperatures reach 80 degrees F. and repeat every 2 months. **NOTE:** for control of white grubs (larva of European Chafer and Japanese Beetle) use at 2 - 4 pounds per 1,000 sq. ft. where infestation occurs. For best results, treat when grubs are young and actively feeding near the soil surface, usually during late July or August. Consult your local Cooperative Agricultural Extension Service specialist for proper time to treat in your area. Apply Lawn Medic uniformly with a spreader and water immediately. Do not mow lawn for 24 hours following treatment.

CONTAINER DISPOSAL: "Do not reuse empty container. Destroy it by perforating or crushing. Bury or discard in safe place away from water supplies."

WARNING: KEEP OUT OF REACH OF CHILDREN

MAY BE HARMFUL IF SWALLOWED Do not take internally. Avoid eye contact. Flush contaminated eyes with plenty of water, and get medical attention if irritation persists. Wash thoroughly after handling. Wash contaminated clothing before re-use. Keep children and pets off treated area until Lawn Medic is watered into the soil and the area is dry. Keep away from food, feedstuffs and domestic water supplies. Keep container closed. **NOTE TO PHYSICIAN:** Chlorpyrifos, is a cholinesterase inhibitor. Treat symptomatically. Atropine is an antidote.

USE PRECAUTIONS

This product is toxic to fish, birds, and other wildlife. Keep out of lakes, streams, or ponds. Do not apply where runoff is likely to occur. Do not apply when weather conditions favor drift from areas treated. And as stated above, keep children and pets off treated areas until product is watered into the soil and the area is dry. Do not contaminate water by cleaning of equipment, or disposal of wastes. Apply only as specified on this label.
