DIRECTIONS FOR USE

LAWN MEDIC CRABGRASS PREVENTER #1 is recommended for pre-emergence control of annual wearly grasses such as crabgrass (smooth and hairy) foxtail, and barnyardgrass in newly seeded or established plaintings of the totowing grasses only: Bluegrass, Fescue, Redtop, Smooth Brome, Perennial Ryegrass, Orchardgrass, and the following strains of bent grass: Penncross, Seaside, Highland, Astoria, Nimisila, C-1, C-7, and C-19. Do not use on other strains of bentgrass nor on Bermudagrass as injury to turf may result. Use on golf greens is not recommended as injury to turf may result. Treatment will not control annual bluegrass (Poa annua), clover or most broadleaf weeds.

.AWN MEDIC CRABGRASS PREVENTER #1 may be applied at any stage of turf development including new seedings. At least 1/2 inch of water must be provided by rainfall or irrigation within 3 days after treatment in order to carry the chemical into the root zone of germinating weeds.

AMOUNT TO USE — WHEN TO APPLY

ESTABLISHED TURF AND NEW FALL SEEDINGS: Apply in Spring just before expected emergence of annual weed grasses at 3 lbs, per 1000 sq. ft.

SPREADER SETTING: CYCLONE 4.

NEWLY CONSTRUCTED SPRING LAWNS: Apply as final operation following seeding at the rate of 1 1/2 pounds per 1,000 sq. ft..

SPREADER SETTING: CYCLONE 3.


