Revise: "Etofenprox Technical is an insecticide for formulation into pesticide products intended for use in indoor non-food/feed areas and outdoor areas of residential, commercial and industrial establishments, and as a wide-area mosquito adulticide and to rice." to read: "Etofenprox is an insecticide for formulation into pesticide products intended for use in rice fields, indoor and outdoor non-food/feed areas of residential, commercial and industrial establishments, and


outdoors as a wide-area mosquito adulticide.

3. You will submit/cite all data required for registration/reregistration of your product under FIFRA section 3 (c) (5) or 4(a) when the Agency requires all registrants of similar products to submit such data.
