a. Add a statement to the front panel to identify this product as manufacturing use concentrate or formulation intermediate. You may modify "For Formulation into Insecticide Products" to "Manufacturing-Use Concentrate for Formulation into Insecticide Products".

b. Under First Aid, move the statement for "If in Eyes" to the top, since this is the most hazardous exposure route. This should be followed by followed by oral and dermal exposure statements.

c. Under Directions for Use, change the first paragraph as follows: "Dinotefuran TK is intended for use only in the formulation of insecticide products used in the control of sucking, biting and chewing insects infesting leafy vegetables (except Brassica), turf and ornamentals, domestic outdoors, (lawns, perimeter, and ornamentals), and certain public health pests." Delete the second paragraph.

d. Under Directions for Use, change the last statement as follows: "Products formulated from this manufacturing concentrate will require registration with the U.S. Environmental Protection Agency (EPA)."

e. Under Storage and Disposal, add the following restriction under Pesticide Storage: "Do not store in metal containers." This restriction will be reconsidered after submission and review of the study testing stability to metals and metal ions for the source product Dinotefuran Technical. Should the study demonstrate Dinotefuran Technical to be reactive to metals and metal ions, you will be required to add this storage restriction to the end-use products formulated from this product.

3. The confidential statement of formula (CSF) dated August 9, 2004 is conditionally acceptable. For consistency between the label and CSF the term "Extremely Flammable" must be cited in box 9 of the CSF.

4. This registration is subject to the time frames for submission of generic data for the active ingredient, as indicated in the Notice of Registration for Dinotefuran Technical, EPA Registration Number 33657-10.

5. Submit production information (gallons produced) for this product for the fiscal year in which this use is conditionally registered, in accordance with FIFRA section 29. The fiscal year begins October 1, and ends September 30. The production information will be submitted to the Agency no later than November 15, following the end of the preceding fiscal year. 6. Submit revised CSF and two (2) copies of your final printed labeling before you release the product for shipment.

A copy of the last chemistry review is also enclosed for your perusal.


