d) Based on the positive finding for skin sensitization revise the **general precautionary statement** to read:

2. Change the chemical-resistant gloves to “such as barrier laminate, nitrile rubber, neoprene rubber, Viton, Selection Category E”

ii. RICE: Change the directions for the release time for water after application is made to read: “Permanent flood waters may not be released until 7 days after application.

h) Storage and Disposal: Container Disposal: Nonrefillable container. Do not reuse or refill this container. Triple rinse (or equivalent) then offer for recycling if available, or puncture and dispose of in a sanitary landfill, or by incineration, or if allowed by State and Local authorities, by burning. If burned, stay out of smoke.

Cut off application equipment to avoid treating adjacent roads, field drains, ditches, banks, and other non-target areas. Apply Trebon 3G only when weather conditions are calm to prevent misplacement of granules. Avoid making application under conditions where uniform coverage cannot be obtained or where excessive drift may occur.

RICE: To control Rice Water Weevil, apply 6 to 9 lbs of Trebon 3G per acre (2.9 to 4.3 oz. a.i./A) 1- 7 days after flooding. Trebon 3G should be applied only when adults are present in a field and conditions are favorable for oviposition. Do not make more than one application per season. Permanent flood waters may not be released until 21 days after application.
