  - a. Change the heading from "Inerts" to "**Other Ingredients**".
  - b. Change the order of the First Aid statement so that the "If in Eyes" statement is first.
  - c. It is recommended that additional text be added to the Note to Physician section that addresses eye irritation concerns.
  - d. Change the company address to "4032 Crockers Lake Boulevard, Suite 818, Sarasota, FL 34238".
  - e. Change the Hazards to Humans and Domestic Animals statement to read as follows:

**"DANGER Corrosive. Causes irreversible eye damage. Harmful if swallowed, absorbed through skin, or inhaled. Do not get in eyes, or skin, or on clothing. Avoid breathing dust."**

- f. The PPE text "Wear goggles or face shield when handling." may remain on the label.
- g. Under Directions for Use, change the site "Small Grains" to read "**Small Grains (Barley, Proso Millet, Oats, Rye, and Wheat)**".
- h. Change the Pesticide Disposal phrase to "**must** be disposed of".
- i. Change the Container Disposal section to read as follows:

**Nonrefillable containers – Metal:** Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container ¼ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling if available or reconditioning if appropriate, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.

**Fiber Drums with Liners:** Do not reuse or refill this container. Completely empty liner by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into application equipment. Then offer for recycling if available, or dispose of liner in a sanitary landfill or by incineration or, if allowed by state and local authorities, by burning. If burned, stay out of smoke. If drum is contaminated and cannot be reused, dispose of it in the manner required for its liner."
