

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable with the following provision:

Due to new EPA policy, part of the Environmental Hazards section has been changed. To comply, change the sentence "Do not apply directly to water or wetlands" to read "Do not apply directly to water, to areas where surface water is present or to intertidal areas below the mean high water mark."

The revised basic and alternate Confidential Statements of Formula dated May 6, 1991 are acceptable and have been added to your file as part of the record.

#### APPLICATION DIRECTIONS:

For crabgrass, goosegrass, and annual bluegrass (*Poa annua*) control in established turf. Successful preemergence control of the weeds listed on this label requires proper timing of application. NO CRAB controls annual grassy weed seeds as their germinate. Apply NO CRAB before these annual weeds begin to germinate since it does not control established weeds. In areas of the United States where germination of these annual grassy weeds may occur for an extended period of time, a second application of NO CRAB at the recommended rate may be made ten to twelve weeks after the initial application for extended control. Rake turf area free of leaves, sticks, or other materials. Measure area to be treated, calibrate spreader and uniformly apply the required amount. Cross treating with one half the required amount in each direction will give best results. Be sure to shut off the spreader when stopping or turning around. Do not apply to wet turf. Check hopper occasionally to assure material is flowing freely. Water in lightly if no rain falls within a week atter application. Do not water to the point of runoff. Cultural practices that disturb the soil, such as aerification or verticutting, should be done prior to the application of NO CRAB.

#### For crabgrass control in established turf.

For preemergent control, apply 175-260 pounds per acre (4 to 6 pounds active ingredient) or 4 to 6 pounds per 1000 sq. feet in the spring one to two weeks prior to seed germination. Application made after March or April may not be fully effective.

#### For goosegrass control in established turf.

For preemergent control, apply 260 pounds per acre (3 pounds active ingredient) or 6 pounds per 1000 sq. feet one to two weeks prior to seed germination. Although classified as a summer annual, goosegrass normally germinates four to six weeks later than c. grass Single applications of NO CRAB made specifically for the control of goosegrass should be timed accordingly.

#### For annual bluegrass (Pos annua) control in established turf.

For preemergent control, apply 260 pounds per acre (6 pounds active ingredient) or 6 pounds per 1000 sq. feet in late summer or early fall one to two weeks prior to seed germination. Single applications of NO CRAB made specifically for the control of annual bluegrass should be timed accordingly.

#### **RESEEDING:**

This product should be used only on established turf. Do not use NO CRAB on young spring seeded turf as injury or reduced stand may result. Seeding into treated areas should be delayed until three months after application. Fine leaf feacues, bentgrasses, and dichondra may show temporary injury when treatments are followed by

excessive rains and cold temperatures. Do not apply in areas underlayered by roots of desirable trees or shruba. Buffalograss (Buckloe dactyloides), is tilled by this product and should not be treated.

Do not contaminate water, food, or feed by storage or disposal.
