
Submit one copy of your final printed labeling before you release the product for shipment.

INSTRUCTIONS FOR FORMULATION

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

Only For Formulation Into a Herbicide, for (1) the following uses: Corn (Pop and Field), Non-residential turf, mint, garlic, onions, wheat, barley, oats, rye, triticale, seedling alfalfa, sorghum, flax, grasses grown for seed or sod production and Conservation Reserve Program Areas.

(2) Uses for which USEPA has accepted the required data and/or citations of data that the formulator has submitted in support of registration and (3) Uses for Experimental Purposes that are in compliance with USEPA requirements.
