{Non-Refillable containers}

Non-refillable container. Do not reuse or refill this container. Offer for recycling, if available. Triple rinse empty container (or equivalent) promptly after emptying. Triple rise as follows: Empty the remaining contents into application equipment or mix tank. Fill the container ¼ full with water. Replace and tighten closures. Tip container on side and roll back and forth, ensuring at least one complete revolution, for 30 seconds. Stand container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two or more times.
