## ISOCYANURATE RED ATTACHEMENT A

**LABELING:** (Statements are based on review of referenced acute toxicity data)

1. The signal word is "DANGER"
2. Revise the Precautionary Statements to read:

CORROSIVE: Causes irreversible eye damage and skin burns. May be fatal if absorbed through skin. May be fatal if inhaled. Do not breathe dust or spray mists. Irritating to nose and throat. Harmful if swallowed. Do not get in eyes, on skin, or on clothing. Wear goggles or face shield, protective clothing and rubber gloves when handling this product. Wash thoroughly with soap and water after handling and before eating, drinking or using tobacco. Remove contaminated clothing and wash before reuse.

3. Revise the Statement of Practical Treatment to read:

## **PRECAUTIONARY STATEMENTS**

**Hazard to Humans and domestic animals:**

**DANGER:** Corrosive. Causes eye and skin damage. Do not get in eyes, on skin or on clothing. Wear goggles and rubber gloves when handling. May be fatal if swallowed. Avoid breathing dust. Wash thoroughly with soap and water after handling.

**ENVIRONMENTAL HAZARD:** This pesticide is toxic to fish and aquatic organisms. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or public waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge effluent containing this product to sewer systems without previously notifying the local sewage treatment plant authority.
