Hazard to Humans and Domestic Animals:

**DANGER:** Corrosive. Causes eye and skin damage. Do not get in eyes, on skin or on clothing. Wear goggles and rubber gloves when handling. Harmful or fatal if swallowed. Avoid breathing dust. Wash thoroughly with soap and water after handling.

**ENVIRONMENTAL HAZARD:** This product is toxic to fish. Do not discharge into lakes, streams, ponds or public waters unless in accordance with NPDES Permit. For guidance, contact the Regional Office of EPA.

**PHYSICAL OR CHEMICAL HAZARD:** Oxidizing material. Avoid contact with combustible materials. Keep away from all sources of heat, flame or sparks. At elevated temperatures (above about 325°F) a self propagating thermal decomposition may occur with resultant irritating and toxic gases. In case of fire, flood with large quantity of water. In the event of contamination or decomposition, do not reseal container.

STORAGE AND DISPOSAL

**STORAGE:** Retie polyethylene liner after each use and keep container tightly closed. Store in a dry place. Do not allow water to get into container. Keep container off wet floors. Do not contaminate water, food or feed by storage or disposal.

**DISPOSAL:** Wastes of this pesticide may cause irreversible eye damage and burns to skin and may be dangerous. Improper disposal of excess pesticide, spray mixture or rinsate is a violation of Federal law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office for guidance.

**CONTAINER DISPOSAL:** Completely empty liner by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into application equipment. Then dispose of liner in a sanitary landfill or by incineration if allowed by State or local authorities. Rinse empty container with water, and dispose of in the same manner.
