The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable provided you make the following label changes.

1. Under the Hazards to Humans and Domestic Animal, the statement "Avoid inhalation of dust..." is present. Therefore the If Inhaled statement must appear in the first aid statement. Please add the If Inhaled statement after the If on Skin and Clothing as follows:

If Inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice.

You must submit two (2) final printed label before you release the product for shipment. A stamped copy is enclosed for your records.

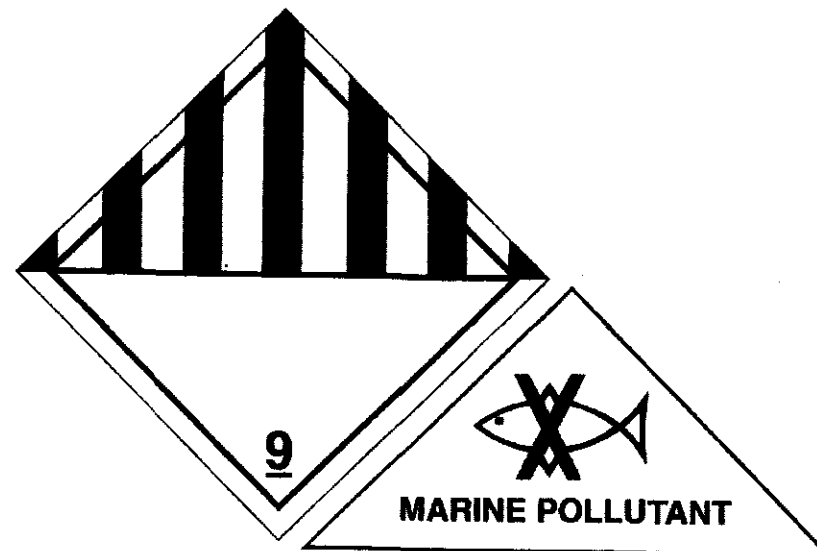
