The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, As Amended (FIFRA), is acceptable, provided that you submit one copy of your final printed label for the subject product incorporating the following correction before you release the product for shipment.

1. This labeling falls under the scope of the Worker Protection Standard (WPS) and must bear the required WPS statements as outlined in PR Notices 93-7 and 93-1. The new protective language must be incorporated into this label for any shipments released after the deadlines that have been established. You may opt to do so immediately if you are electing the self-verification option.

If it is your intention that the product be marketed only for use by the homeowner, appropriate language must be added to the label to remove it from the scope of the WPS.
